Join us for the 1st annual Artisans In The Park Summer Fest at the Ephrata Cloister which will be held on Saturday, June 29, 2019 from 9am – 4pm. This event is held the fourth Saturday in June every year at 632 West Main Street, Ephrata, PA 17522 which is located off Route 322, at the historical Ephrata Cloister, less than one hour from Hershey, Harrisburg, Kutztown, Reading, Lancaster, Lititz West Chester and York.

The space fee is \$100 per 10'x20' and you must provide your own tent/canopy, tables, table cloths and chairs. There is a \$25 discount for each additional space (2 spaces = \$175). Please email me directly with any other set-up/space requests or questions.

Set up can be done Friday starting at noon (there is overnight security) thru Saturday, but must be complete by 8:30am on Saturday. The show begins promptly at 9am. The show concludes at 4pm and is held rain or shine. All vendors are expected to stay the length of the show and there are no refunds for cancellations. There is easy unloading and loading and vendor parking in close proximity. For safety reasons, no vehicles are permitted in show areas from 8:30am-4:10pm.

Spaces are filled on a first come, first serve basis and there is a max of 1 food vendor per food type. Vendors may only bring/sell the items that they have listed on their application. If the food item that you specialize in is already being fully represented, I will contact you to return your show fee and discuss our waiting list options. Drink items may not be exclusive.

Food Vendors are responsible for obtaining all necessary license(s) from the Pennsylvania Department of Agriculture. All booths must be in compliance with the Pennsylvania Department of Agriculture rules.
